

# R&F Steel Buildings FarmFest 2026 Competition

## Official Terms & Conditions



### 1. Promoter

The promoter is R & F Steel Buildings Pty Ltd [ABN 69 143 902 22998] of 98 Crescent St, Gatton QLD 4343 ("Promoter").

### 2. Eligibility

- a) Entry is open to Australian residents aged 18 years or over, **excluding residents of South Australia.**
- b) Employees of the Promoter and their immediate family members are not eligible to enter.
- c) No purchase is necessary to enter.

### 3. Competition Period

The promotion commences on **Tuesday 2 June 2026 and closes at 5:00pm AEST on Friday 19 June 2026.** Entries received after this time will not be accepted.

### 4. Entry Requirements

To be eligible, entrants must be following @rfsteelbuildings on either Facebook or Instagram at the time of entry and at the time the winners are drawn. Entrants may enter using either or both of the following methods:

- **Entry Method 1 – Sticker & Photo Entry:** Entrants receive three (3) entries for each valid photo entry by following @rfsteelbuildings on Facebook or Instagram, displaying an official sticker received at FarmFest 2026, taking a photograph featuring the sticker, and posting it to Facebook or Instagram while tagging @rfsteelbuildings. Multiple photo entries are permitted, provided each submission features a different photograph and sticker location.
- **Entry Method 2 – Comment Entry:** Entrants receive one (1) entry by following @rfsteelbuildings on Facebook or Instagram and commenting "SHED YEAH" on an official competition post during the competition period. Only one comment entry per platform per person will be counted.
- **Account Visibility: Social media profiles must be set to 'public' for the duration of the competition period. If an account is private, the entry and tag will not be visible to the Promoter and cannot be counted.**

### 5. Entry Conditions

Entrants warrant that:

- a) The content submitted is their original work.
- b) They have permission to photograph and publish any property, machinery, vehicles, worksites, or locations shown.
- c) The content does not infringe the rights of any third party.
- d) The content complies with all applicable laws.

The Promoter reserves the right to verify entries and reject any entry that does not comply with these Terms and Conditions.

### 6. Sticker Placement & Property Damage

For safety and legal reasons, stickers must not be placed on road signs, traffic control devices, public infrastructure, property without permission, locations that create a safety hazard, or any location where placement would breach applicable laws. **The Promoter accepts no responsibility or liability for any property damage, paint marking, residue, degradation, or costs associated with the application, display, or subsequent removal of the sticker.**

### 7. Prohibited Content

Entries must not contain or depict unsafe work practices, reckless vehicle/machinery operation, illegal activities, offensive/discriminatory content, dangerous behaviour, or content that may bring the Promoter into disrepute. The Promoter may remove or disqualify any entry that breaches these requirements.
